Kindergarten-Eighth Grade

Registration

January 3rd-January 31st (Re-enrollment for current students and enrollment for siblings of current students and Redeemer Church member children)

\$475.00 = 1st child

\$375.00 = each additional child in K-8th

February 1st-February 28th (Open Enrollment)

\$475.00 = 1st child

\$375.00 = each additional child in K-8th

March 1st-31st

\$550.00 = 1st child

\$450.00 = each additional child in K-8th

April 1st and thereafter:

\$595.00 = 1st child

\$495.00 = each additional child in K-8th

The Registration Fee is paid at the time the Commitment Form and the Acceptable Use Form are submitted to the school office. The Registration Fee is non-refundable.

The Registration Fee covers the following: rental of textbooks, purchase of consumable workbooks, classroom instructional supplies, Stanford Achievement Testing materials and scoring, student accident insurance, technology fees and supplies, classroom funds, school association fee (PTO), library expenses, fine arts programs (drama, music, art), and two tickets to the Annual Auction.

The Registration Fee does not cover the following: school pictures, yearbook, hot lunches, field trips, and other incidentals.

Redeemer Lutheran Church and School is a not-for-profit organization. The school admits students of any race, color, national or ethnic origin.

Tuition Payment Options

Option A—Cash, Check, Cashier's Check, or Electronic Funds Transfer Discounted Annual Payment by July 31, 2012

Kindergarten—8 th grade (1 st child)	= \$5,760.00
Each additional K-8 th grade child	= \$5,184.00

Option B—Automatic Withdrawal

Funds will be drawn from a checking or savings account the first business day of the month starting in August of 2012 and finishing on May 1, 2013.

Kindergarten-8 th grade (1 st child)	= \$6,000.00 [\$600/month]
Each additional K-8 th grade child	= \$5,400 [\$540/month]

Option C—10-Month Payment starting in July of 2011

Tuition shall be paid with cash, check, cashier's check or electronic funds transfer on the first of the month starting on July 1, 2012 and finishing on April 1, 2013.

Kindergarten-8 th grade (1 st child)	= \$6,000 [\$600/month]
Each additional K-8 th grade child	= \$5,400 [\$540/month]

Discounts

As shown in Option A above, families receive a cash, check, cashier's check, or electronic funds transfer discount if the tuition is paid in full by July 31, 2012. Additional children receive a 10% discount per student (does not apply to pre-kindergarten programs). Active members of Redeemer Lutheran Church also receive a \$1,000 scholarship (off the gross tuition amount) per child attending K-8th grade.

Late Fees and Penalties

Tuition shall be due and payable in full on or before the first day of each month. Please contact the business office regarding payment options. Tuition collected after the 10th of each month will automatically incur a \$30 late fee or 10% of the outstanding balance, whichever is less. NSF check fee or returned EFT is \$30.

Other Fees and Expenses

For every K-8th grade student entering Redeemer for the first time or returning to the school after attending another school, the application fee is \$30 and the Testing Fee is \$100.

Parents purchase school uniforms from an independent distributor; uniforms are not covered by tuition or the registration fee. You are welcome to the uniform closet, which has lightly worn uniforms free of charge.

Congregational Support

Tuition payments do not cover the true cost of our students' education. The members of Redeemer Lutheran Church believe firmly in the importance of Christian education, so the congregation is subsidizing the school with more than \$100,000.00 for the 2012-2013 school year. [Financial Aid is available on an as-needed basis. Contact the school office for an application packet.]
