# Redeemer Lutheran School Stuart, Florida Application for Financial Assistance

#### ALL INFORMATION IS CONFIDENTIAL

- 1. Please make sure that you answer all the questions completely and provide <u>all</u> requested documentation. Your application will not be processed unless you provide all of the necessary information.
- 2. Financial assistance will be awarded on the basis of financial need and student potential, not as rewards for academic or other performances.
- 3. The guidelines for receiving financial assistance are as follow:
  - a) Families with a gross income of less than \$25,000 shall be given first preference.
  - b) Families with a gross income of \$25,000-\$35,000 will be given second preference.
  - c) Families with a gross income of \$35,001-\$45,000 will be given third preference.
  - d) Families with a gross income of more than \$45,000 will be given last preference. The committee that reviews the financial assistance applications will be sensitive to family situations that include but are not limited to sudden sickness, large medical bills, loss of job, loss of home, divorce, and disability. The committee will also take into consideration if two or more children in the family are eligible for enrollment in Redeemer Lutheran School. Each application will be reviewed on a case-by-case basis, regardless of income. Special consideration will be given when possible.
- 4. Financial assistance will be awarded for one school year. If financial assistance is required the following year, you must complete the application process again.
- 5. Once the committee reaches a decision, you will be notified by telephone, by email, or in person. If you are awarded financial assistance, the bookkeeper and the business manager will be notified and will adjust your tuition payments accordingly.
- 6. Besides completing the forms in this packet, we must receive photocopies of your last two years' tax returns (1040's and related forms) and your last two years' W2 forms or 1099 forms and copies of your last two paycheck stubs if you receive paycheck stubs.
- 7. If your financial situation improves significantly during the school year, we request that you notify us so that some of the assistance that you would receive can be reallocated to another family that is experiencing even more serious financial difficulty.
- 8. As part of receiving financial assistance, we expect your family to attend the four worship services that the students actively participate in, as well as volunteer in some capacity during the school year.
